

Standard

FAMILY DAYHOME STANDARDS MANUAL FOR ALBERTA

This manual contains the standards for Dayhomes and Dayhome agencies to provide child care.

Every month we will review a Standard.

Standard 4C: Outdoor Play Space

Alberta 🗖

The program must ensure that children have access to outdoor play space.

If the outdoor play space is part of the program residence, it must be securely enclosed. If the outdoor play space is not part of the program residence, it must be within a safe and easy walking distance. The agency can exempt a program, using a CS-approved form, from the requirement to have the outdoor play space securely enclosed if outdoor play space that is securely enclosed is not reasonably available and if children will be adequately supervised and protected in the outdoor play space provided.

The form used to exempt a program must be approved by CS annually and any changes to the form must be pre-approved by CS. A copy of the exemption form must be stored on the program's record with the agency and parents must be informed at the time of enrolment that the program has an exemption.

<u>Agency Response</u>: On the survey, we asked our educators "In order for families to choose family dayhomes as a viable childcare choice, they need to access back-up care when their dayhome is closed. Do you provide backup care? Why or why not?

Educator Reponses:

"Why? because I want to help those families in need of back up care. Why not? Child is new to the dayhome and not adjusted to the environment and children in care sometimes get confused."

"Support families and my colleagues. And I might need my colleagues to support the families in my caseload if I need a day off."



"I believe all educators under this agency should help each other whenever needed"

"As of now, I am not providing it due to a family member health conditions! I need to have same families just to make sure that we're staying in good health for now, in the future -yes I would be able to provide back up care!"
