The Children and Family Services Department (CFS) Early Years Team at the Otipemisiwak Métis Government is excited to announce the Day Home Startup Pilot Program. This program aims to support Métis Albertans in opening licensed day homes, and is made possible in partnership with Apeetogosan Métis Development Inc.

The Day Home Startup Program will support Métis Albertans in opening licensed day homes committed to providing culturally appropriate programming for Métis children and families seeking childcare in Alberta. These day homes will create safe spaces for Métis children to learn and grow, which can serve as a protective factor and strengthen their cultural identity and sense of belonging.

The Day Home Startup Program is a two-year Pilot Program with the hope of continuing in the future.

Who is Eligible for the Program?

In order to be eligible for the program, successful applicants must be current residents of Alberta as well as current citizens of the Otipemisiwak Métis Government of the Métis Nation within Alberta (previously the Métis Nation of Alberta).

Successful applicants must be *18 years of age or older* and own the home in which they intend to operate the day home (or live in Métis Urban Housing - this is being clarified with our legal team).

Successful applicants must be willing to operate a Licensed Family Day Home incorporating elements of Métis culture for at least two full years and must be able to meet all the requirements of a Licensed Family Day Home Agency as well as any additional regulatory requirements outlined by the Day Home Licensing Agency.

Finally, successful applicants must demonstrate a personal financial commitment equivalent to 10% of the total grant amount. This amount will be reimbursed to the applicant after two years of compliant day home operation.

What Supporting Documents are Needed to Apply for the Program?



After the online application form is approved, the successful applicant will be required to provide the following supporting documents.

Licensing Required Documents:

- Proof of age documentation
- Proof of home ownership (may also be able to qualify if living in Métis Urban Housing)
- A clean criminal record and vulnerable sector check for all adults who will be in the home during day home operating hours
- A statement disclosing prior criminal involvement of all people under 18 who will be in the home during day home operating hours
- Three satisfactory references from non-relatives that corroborate suitability working with children
- Childcare First Aid Certificate
- A physician's note stating that the applicant is mentally and physically able to work with children
- Early Childhood Education Level 1 Certificate (to be completed within 3 months of approval)

Apeetogosan Required Documents:

- A Void Cheque
- A budget submitted for approval outlining startup costs (based on the sample budget provided by the CFS team)

What is Apeetegosan's Role in the Program?

Apeetegosan, as an affiliate of the Otipemisiwak Métis Government, will support the financial aspect of the program.

Is this a Loan or a Grant Based Program?

This program is a grant-based program. All financial transactions will be made through the Otipemisiwak Métis Government affiliate Apeetogosan.

What is the Grant Amount?



Successful applicants will receive a one-time \$20,000 grant.

How Will the Grant Funds be Allocated?

The grant funds will be paid out to the successful applicant in two installments.

The first deposit will be made after the applicant meets with the licensing agency and provides a budget outlining the preliminary costs related to opening a day home and meeting licensing requirements.

The second deposit will be made four months after the initial deposit. All purchases made with the grant money must be documented and accompanied by a receipt that will be submitted to Apeetogosan for tracking purposes.

Why do Applicants Need to Provide a Financial Commitment?

To receive the grant funds, applicants must provide Apeetogosan with a deposit equivalent to 10% of the grant funding (\$2,000). This security deposit represents a commitment to operate a day home for the two-year period required to receive the grant funding. This security deposit will be reimbursed to the applicant once they have reached the two-year commitment required to obtain grant funds.

What is the Role of the Licensing Agency?

The licensing agency provides training for day home educators and monitors for compliance with the family day home standards. Licensing agency consultants help family day home educators to develop programs for children at different stages of development and provide advice about nutritious meal planning.
